Presenter Biographies

Keynote Presenters

Steve Siemens, CSP, is CEO/head people builder of Siemens People Builders located in Des Moines, Iowa. Mr. Siemens "builds" people in a variety of settings. He has spoken in every state in the U.S. and in 22 countries. Mr. Siemens has been labeled as one of the best professional speakers in the nation. He is the author of three books, *Together We Can, Together We Will, Together We Did; Give Stress A Rest* and *Push-Ups For People.* He was awarded the Certified Speaking Professional (CSP) designation by the National Speakers Association. It is the highest designation given by NSA. He is one of only 10 percent of professional speakers worldwide who has met the rigorous standards. Mr. Siemens is a past college president and has served as a professor in three other colleges.

Eric Coleman, MD, MPH, is professor of medicine and head of the Division of Health Care Policy and Research at the University of Colorado Anschutz Medical Campus. Dr. Coleman is the director of the Care Transitions program, aimed at improving quality and safety during times of care "hand-offs". He is also the executive director of the Practice Change Fellows program, designed to build leadership capacity among health care professionals who are responsible for geriatric programs and service lines.

Joseph A. Allen, PhD, is an assistant professor, I/O Psychology, University of Nebraska at Omaha. Dr. Allen is a premier expert on huddles and debriefs, including recent publications in *Accident Analysis and Prevention*, as well as the *Journal of Applied Psychology*. Dr. Allen is an investigator on the CAPTURE Falls program with particular focus on post-fall huddles. The purpose of this project is to use inter-professional teams, organizational learning and a culture of safety to decrease the risk of falls in Critical Access Hospitals.

Leanne Bewley LPN-C, PhT, is a 2002 nursing graduate from Colby Community College in Kansas. She received her LPN-C from Central Community College. She joined Harlan County Health Services in 2004. She is registered as a pharmacy technician and has focused on pharmacy services for the last two years. She received training from Omnicell and is a Certified Omnicell System Administrator. She was previously employed as a floor nurse at Norton County Hospital in Kansas.
