## YOUR ASSOCIATION. YOUR RESOURCE.

Dear valued member,

As I reflect upon 2016, it is hard for me not to think forward and anticipate what 2017 has in store for the Nebraska Hospital Association, which will be the 90th Anniversary as your Association. The NHA relies on the willingness of members to collaborate with hospitals to achieve success. Our success is an endeavor we enjoy working on with you, our members.

This following report highlights many of the successful advocacy and representation efforts that, together, we achieved on behalf of Nebraska hospitals and health systems. With the support of committed members and in collaboration with your Association, we advocated with a common voice in local, statewide and national policy discussions.

The 60-day legislative session convened January 6 and adjourned on April 20, 2016. In total, 445 bills were introduced, with 86 Bills of Interest identified by NHA members, covering a wide range of issues. NHA staff assisted with LB 900, a bill that modified Nebraska's current motorcycle helmet requirements and creates several new provisions. Another bill staff assisted with was LB 721. This bill creates a scope of practice for surgical first assistants and a pathway to licensure for this health care occupation. The bill requires that a licensed surgical first assistant performs delegated tasks only under the personal supervision of a surgeon.

To maintain our excellent caliber of educational programs, we partnered at the federal and state level with other health care educational organizations to find new ways to improve the health care delivery system. In this year's annual report, we are sharing our success stories of innovation and coordination.

The NHA health data and information team continues to provide reliable and comprehensive health data and information regarding health care services, health care trends, clinical outcomes, and their impacts and implications on Nebraska health care providers and the communities they serve.

Nebraska's hospitals continue their strong tradition of improving the quality of health care. The NHA and fifty-six member hospitals participated in the American Hospital Association's Health Research & Education Trust (AHA HRET)/NHA Hospital Engagement Network (HEN). As a part of this national effort, our ambitious goals were to reduce the incidence of patient harm in the areas of central line-associated blood stream infections (CLABSI), catheter-associated urinary tract infections (CAUTI), ventilator-associated events (VAE), surgical site infections (SSI) involving colon, knee, hip and abdominal hysterectomy procedures, falls, adverse drug events, pressure ulcers, venous thromboembolism (VTE), early elective deliveries (EED) and other OB harm by 40 percent and readmissions by 20 percent.

NHA staff actively communicates with Nebraska's congressional delegation, the Centers for Medicare & Medicaid Services, the American Hospital Association and other stakeholders on a frequent basis regarding health care provisions being proposed and implemented. Through advocacy efforts, the NHA and our members are able to influence federal policy and its impact on Nebraska hospitals.

In the coming year, with the contribution and support of our membership, I know the NHA can once again achieve its goal of being the influential and unified voice for Nebraska's hospitals and health systems.

Your participation in the Association has never been more important. Thank you for your continued support.

## THE INFLUENTIAL VOICE.

Nebraska's hospitals serve as health and wellness cornerstones and economic engines of their communities and the state. For decades, hospitals have been committed to strengthening not only their patients, but also the communities and regions they serve. In addition to caring for the injured and serving the health needs of area residents, for many communities, hospitals are the largest employer and most stable economic driver.

Hospitals contribute significantly to the goal of improving the overall health of Nebraskans, all the while focusing on aiding the less fortunate as part of their mission and purpose. Hospitals care for the sick and injured, regardless of their ability to pay and the net cost to the hospital. Charity care results from a hospital's policy to offer health care services free of charge or on a discounted fee schedule to individuals who meet predetermined financial criteria. Often, the extent of how much hospitals contribute to the betterment of their communities and the state is neither recognized nor understood. Regardless of awareness, Nebraska's hospitals are committed to addressing the critical and necessary needs of their communities in a responsible, considerate and compassionate way.

## MAKING AN IMPACT. TAKING THE LEAD.

The 2016 Nebraska Legislature adjourned Sine Die on April 20, 2016. The legislature **introduced 445 bills** during this 60-day session, focusing much of their time on the state's budget, taxes, corrections and school funding.

216 bills were signed into law, with an additional 66 bills originally introduced as separate measures that were then amended in to the 216 and passed as a package. The Legislature selected 107 bills as priorities, and 76 of those priorities were passed in to law. Notably, not all priority bills were considered this year due to time constraints and four priority bills that were advanced to the floor did not receive debate.



## During this session, the NHA's members:

- Identified 86 of the 445 bills as Bills of Interest
- Supported 15 bills
- Opposed 4 bills
- Monitored 65 bills

The NHA submitted written testimony on 10 bills and testified in-person on 8 bills before 8 of the 14 standing committees.

## Notable bills signed into law:

- **LB 47** Anatomical Gifts Under the Motor Vehicle Operator's License Act
- **LB 471** Prescription Drug Monitoring Program Prohibits patients from opting out; requires all prescriptions be entered; all prescribers and dispensers have access at no cost; and includes all payers.
- LB 680 Change Certification Requirements For Pharmacy
  Technicians
- LB 721 Surgical First Assistant Practice Act (Priority) creates a scope of practice for surgical first assistants and a pathway to licensure for this health care occupation. The bill requires that a licensed surgical first assistant performs delegated tasks only under the personal supervision of a surgeon. The Board of Medicine and Surgery shall waive certain licensure requirements for surgical first assistants who have functioned in the role within the last five years. It is estimated that 15-25 surgical first assistants currently reside within Nebraska and that this number will increase once the State recognizes this occupation.

## ADVOCATING FOR HEALTH CARE FOR ALL.

**LB 722** – Stroke System of Care Act

Sets a regulatory framework for Direct Primary Care (DPC), or direct physician-patient contracting for primary care services, within Nebraska. LB 817 specifically defines DPC as medical services performed outside of the scope of state insurance regulation.

The NHA recognizes that this model supports the transition from fee-for-service health care to value-based models that will define health care as we move toward population health.

LB 816 - DHHS Institutions Patient Records Accessibility

LB 817 – Direct Primary Care Agreement Act (Priority)

LB 849 – Assisting Caregivers Transitions Act (HHS)

LB 891 – Down Syndrome Diagnosis Information Support Act

### Bills incorporated into the budget:

**LB 911** – BH Systems of Care Blueprint (Priority) Appropriates \$200,000 each year for FY17-18 to develop a behavioral health system of care for Nebraska. The plan will include a statewide assessment of needs, including infrastructure, services, support and financing strategies for short- and long-term outcomes.

The NHA has designated increasing access to quality mental and behavioral health services as a top priority and views LB 911 as an important first step in setting a foundation for building a system to help those in need.

LB 923 - Additional funding for FQHCs



LB 769 - Eradication of Gun Free Zone

LB 825 - Reporting for Tax-Exempt Properties

LB 900 - Helmet Law Modification

LB 900 modified Nebraska's current motorcycle helmet requirements and created several new provisions. Under this bill, anyone 21 years of age or older can forego wearing a helmet while operating a motorcycle or moped, as long as he or she wears protective eyewear. LB 900 also created the Motorcycle Safety and Brain Injury Trust Fund, which will obtain revenues from an increase in motorcycle registration fees and increased fines for operating a motorcycle without a license. The bill also prohibits motorcycle passengers under the age of eight.

The NHA assisted stakeholders in opposing LB 900. It failed to advance and did not overcome a filibuster on General File with a vote of 30-17.

LB 1061 - Surgical Technologist Registry

There were **24** filibusters this session, compared to 13 the year before. In the years just before these record breaking numbers, the number of filibusters averaged three to five per session.

The Legislature also voted to override Governor Pete Ricketts' only contested veto of the session. Gov. Ricketts vetoed Sen. Heath Mello's LB 947, which would direct the State to give professional and commercial licenses to qualified individuals who have a legal presence in the United States. The NHA was proud to work in support of the bill and the legislative override.

11 senators ended their legislative careers due to term limits.

## ADVANCING HEALTH CARE EDUCATION.



The definition of commitment is a "pledge, a promise." The meaning of the word commitment for the NHA Research and Educational Foundation (NHA Foundation) speaks to the dedication to our mission to be valuable to NHA member hospitals

by assisting them in remaining current and responding to advances in health care.

Commitment reinforces an acceptance of responsibility to be a leader always driving to innovate and improve. The NHA Foundation embraces this leadership role as we commit ourselves to providing the highest-quality health care education that is affordable, accessible and convenient.

We are partnering at the federal and state level with other health care educational organizations to find new ways to improve the health care delivery system. In this year's annual report, we are sharing our success stories of innovation and coordination. These examples of how NHA member hospitals are utilizing the services provided by the Foundation as we combine the strengths of our collective talents to develop the best education for staff that will benefit our patients. The best of times are ahead of us, as are the greatest challenges.

The Foundation Board of Directors, the **Education Advisory Group** and NHA staff continue to use the opportunity to carve a path that guides, supports and advances our educational mission and the missions of our member hospitals.

In March 2016, the Foundation reconvened its Education Advisory Group. Consisting of employees from various managerial positions within NHA member hospitals from each of the five districts and key organizational partners, including the Nebraska Chapter of the Healthcare Financial Management Association (HFMA), American College

of Healthcare Executives (ACHE), Nebraska Healthcare Marketers (NHM) and Nebraska Organization of Nurse Leaders (NONL), along with representatives of critical access hospital networks, this group assisted NHA staff in efforts to identify the most relevant and high-quality educational offerings and through the most appropriate method of delivery.

The group identified 21 individual breakout sessions for both the Mid-Year Meeting and the Annual Convention, along with face-to-face educational offerings they felt would be most beneficial to member hospitals carrying into 2017.



The Foundation offered and co-sponsored 15 individual educational programs for our member hospitals and their employees. As always, there were the signature events such as the Annual Convention, CAH Conference on Quality, Advocacy Day, Health Care

Administrative Professionals Conference, Mid-Year Meeting and Western Regional Trustee Symposium.

Offered for a second year was the **Physician Leadership Development Conference.** The NHA Board of Directors had expressed the desire for this to become an annual event, but based on attendance and cost, the NHA Foundation Board re-evaluated this and suggested that a track of programs designed for physicians be offered at the annual convention beginning in 2017 instead.

Along with these live events are educational webinars. Webinars and distance learning have increasingly become the most popular delivery method the Association has of providing education to the membership. Webinars initially developed by the NHA Foundation are shared with hospital associations in all 50 states. The Foundation offered more than 120 educational webinars in 2016.

## **GROWING OUR OWN LEADERS.**

### **Leadership Institute**



Class XIII (13) of the NHA Leadership Institute held their opening retreat in January 2016. Participants completed their final session on October 12, 2016. This brings the total number of alumni to 318. This Foundation initiative continues to be the premiere

leadership development program, serving the unique needs of health care employees in the state. Leadership Institute participants benefit from interactive learning with guidance from faculty in various departments from Bellevue University, including business, management and health care administration. Participants gain a great deal from continuous learning and networking throughout the 10-month program. The Institute is not only a gateway to career-long professional development, but it also provides a solid base of knowledge to help individuals position themselves as health care leaders.

The NHA Foundation recently earned the ASAE Power of A Silver Award for the Leadership Institute. The American Society of Association Executives (ASAE) Power of A Awards, the industry's highest honor, recognizes the association community's valuable contributions on local, national and global levels. This award rewards outstanding accomplishments of associations and industry professionals for their efforts to enrich lives, create a competitive workforce, prepare society for the future, drive innovation and make a better world.

### **Hospital Trustee Education Certification Program**



Sixteen hospital boards comprised of approximately 100 individual trustees completed education certification through the Nebraska Hospital Trustee Community Accountability Education Certification Program in 2016. These

boards and individual trustees dedicated the time and effort to governance practices and participated in the quality governance education programs offered by the NHA Foundation and others to ensure governance community accountability. Three NHA member hospitals and health care systems have taken the additional steps in 2016 to become a NHA Board Certified Organization. They have adhered to specific, predefined governance standards that exemplify community accountability and outreach, responsibility for quality and safety of care to address identified needs, and the characteristics of a high-performance board. These boards included the Bryan Health (Lincoln) Board of Trustees, Bryan Medical Center Board of Trustees and Valley County Health System (Ord) Board of Trustees.

### **Western Regional Trustee Symposium**



Nebraska hospital trustees attended the 20<sup>th</sup> anniversary of the Western Regional Trustee Symposium (WRTS) in Phoenix, Arizona on June 8-10. Hospital and health care trustees and executives from Arizona, Colorado, Idaho, Montana, Nebraska, Nevada, New

Mexico, North Dakota, South Dakota, Utah and Wyoming attend this annual event. The program is geared primarily to smaller, rural hospital boards and provides trustees with the tools and governance excellence strategies to navigate the increasingly complex health care environment. Galen Wiser, Trustee from Providence Medical Center in Wayne, completed his fifth year as Nebraska's trustee representative to the WRTS Planning Committee in 2016.

## SUPPORTING HIGH-QUALITY EDUCATION.



careLearning, the e-learning company co-owned by the NHA Foundation and 41 other state hospital associations, continues to see growth. Through careLearning, the Foundation added new online courses for 2016 for members bringing the total number of Nebraska hospital employees enrolled in careLearning online courses to 1,600 out of more than 140,000 nationally.

## **Health Care Career Scholarship Program**



During the past 16 years, the Foundation has awarded over \$500,000 in scholarships, supporting over 300 employees of member hospitals in their efforts to earn a high-quality education.

This year, four additional scholarships were made available due to a generous donation from NHA Affiliate Membership Program participants, FocusOne Solutions and Aureus Medical Group.

According to information provided by HRET, Nebraska's participating hospitals have been able to demonstrate the prevention of an estimated 2,035 areas of harm, representing approximately \$11.8 million in cost avoidance.

Entering its third phase, the Centers for Medicare & Medicaid Services (CMS) has renamed the initiative the Hospital Improvement Innovation Network (HIIN) and once again entered into a contract with HRET and the NHA to continue this important work. The NHA and approximately 60 Nebraska hospitals will partner with HRET and 32 state hospital associations. Networking with hospitals across the nation allows us to share best practices and learn from our peers as we continue our work to improve care in Nebraska's hospitals.

### **Quality Committee**

The NHA's Quality Committee is comprised of CEOs, physicians and senior leaders who are charged with the responsibility to drive the quality improvement process in their facility. A special focus is placed on reducing early elective deliveries, catheter-associated urinary tract infections, central line-associated blood stream infections and preventable readmissions.

The importance of having complete, current statewide information cannot be overstated. As we advocate for appropriate reimbursement and less burdensome regulations, we continue to keep the focus on the patient and what it takes to provide high-quality health care. This information helps us help you tell the story of quality of care in your facility.

## IMPROVING PATIENT EXPERIENCES.

## **Rural QI Steering Committee**

The Rural QI Steering Committee is a highly interactive group of quality directors and chief nursing officers from Nebraska's critical access hospitals (CAHs). Its purpose is to discuss issues of relevance surrounding quality of care in CAHs and offer practical solutions. The annual CAH Conference on Quality is one resource where staff at all levels can come together to discuss issues and learn from the peer-to-peer interaction that takes place during the conference.

### **Leaders in Quality**



Three hospitals were added to be featured in the NHA's Leaders in Quality video series. This year's series focused on the initiatives hospitals are implementing to reduce unnecessary readmissions.

Community Hospital, located in McCook, shared their success in implementing a Community Paramedic Program. With the patient's permission, community paramedics operating within their current scope of work will make visit(s) to the patient in their home. This helps to reinforce the education the patient received in the hospital, as well as improves the coordination of care between the clinic and hospital. The end results are better coordination of care, better understanding by the patient of their role in their care and fewer readmissions.

**Columbus Community Hospital,** located in Columbus, focused on improved communication among the hospital, physician, clinic and area nursing facilities. The hospital created a transitions of care team consisting of case managers and discharge education coordinators whose

goal was to improve communication between the hospital and the patient's post-acute care team. One innovative idea that came out of this group was the creation of 'exchange visits', where staff from one facility meets with staff at another facility to understand each other processes and what they need from each other so that the patient can be successful post discharge.

Lexington Regional Health Center, located in Lexington, focused on better education and care coordination to reduce readmissions. One area of focus was to streamline and provide consistent education to patients, no matter what their medical condition. Patients were educated on the importance of primary care and following up with their physician post discharge. An inpatient care coordinator serves as the conduit between the patient's physician and primary care nurse so that any gaps in knowledge can be immediately addressed. As a result of the success with inpatient care coordination, they have expanded the program to emergency department, obstetrics and chronic care patients.

## PROVIDING RELIABLE & COMPREHENSIVE HEALTH DATA.

### **Health Data and Information**



The NHA provides reliable and comprehensive health data and information about health care services, health care trends, clinical outcomes and their impacts and implications on Nebraska health care providers and the communities they serve.

The Nebraska Hospital Information System (NHIS)

is a signature resource as reliable hospital inpatient and outpatient data. NHIS is the successful result of a coordinated effort between the NHA, Nebraska's community hospitals, Blue Cross Blue Shield of Nebraska and the Nebraska Department of Health and Human Services. Blue Cross Blue Shield of Nebraska and the Nebraska Department of Health and Human Services (NDHHS) continue their financial sponsorship of the NHIS.

The NHA continued refinement of claims data submission process, which included 16 unique processes for NHIS data submission and implementation of ICD-10 on October 1, 2015. ICD-10 is the 10<sup>th</sup> revision of the International Statistical Classification of Diseases and Related Health Problems (ICD), a medical classification list by the World Health Organization (WHO). Partnering with claims clearinghouses to submit claims data on behalf of Nebraska hospitals is an effective method for collection. The NHA added Rycan in addition to nine other clearinghouse options, and coordinated with both hospital information system vendors and clearinghouses to resolve issues.

Reports and information are of critical value to Nebraska hospitals. In addition, the NHIS generates non-dues revenue. The NHA distributed NHIS reports in the prior 12 months for non-dues revenue of \$241,331.

Of this revenue, \$163,881 was from non-member organizations. NHIS marketing materials for services included emails, newsletter information and brochures.

In January 2015, the NHA launched a web portal for the Nebraska Department of Health and Human Services monthly hospital statistical information (1310 report). Participation by hospitals through 2015 and 2016 continued to increase with 123 user accounts.

The NHA compiles Hospital Engagement Network (HEN) reporting measures for 57 HRET participating Nebraska hospitals. Additional reports on quality and patient outcomes for the Clinical Outcomes Measurement System (COMS) were generated from the Truven Care Discovery data load process. NHIS data is also loaded to the NHA Care Compare (NHACareCompare.org) public web portal.

As a benefit to participating hospitals, the NHA continued to provide monthly data to the NDHHS on behalf of Nebraska hospitals for both monthly and annual reporting mandates. Data reporting mandates include the following:

- External Cause of Injury (Neb. Rev. Stat. 71-2078 to 71-2082)
- Head, Brain & Spinal Injury (Neb. Rev. Stat. 81-653 to 81-661)
- Ambulatory Surgical Center (Neb. Rev. Stat. 81-6,111 to 81-6,119)
- Communicable Diseases (Neb. Rev. Stat. 71-532)
- Parkinson Disease Registry (Neb. Rev. Stat. 81-697 to 81-6,110)

The NHA uses the **DATABANK Program** for advocacy and reporting. NHA staff participated in the DATABANK steering committee with the Colorado Hospital Association to evaluate DATABANK developments.

## SHAPING THE FUTURE OF INFORMATION TECHNOLOGY.

## **Health Information Technology**



The NHA participates in **Nebraska Health Information Initiative (NeHII)** to further development of the Nebraska Health Information Exchange and Electronic Health Records.

The Prescription Drug Monitoring Program (PDMP) has been a significant focus of NeHII this year with the passage of LB417. The Nebraska DHHS also received several grants to enhance the existing PDMP and is working with NeHII on implementing a new system by January 2017.

In addition to a new PDMP system, NeHII is converting to a new platform for the health information exchange functionality. NeHII progress is helped by reaching a sustainable financial position in July of 2015 and they continue to add hospitals, physicians and other providers as users. With in-progress hospitals, two-thirds of Nebraska hospital beds will be connected with NeHII.

NHA staff also served on Nebraska Information Technology Commission (NITC) eHealth Council.

The NHA continues to serve in leadership role with the Nebraska Chapter of the Health Information and Management Systems Society (HIMSS). Activities include advocacy, Health IT Week Proclamation and bookkeeping activities. An NHA staff member was recognized as volunteer of the year by the Nebraska HIMSS Chapter.

## INFLUENCING FEDERAL POLICY.



NHA staff actively communicates with Nebraska's congressional delegation, the Centers for Medicare & Medicaid Services (CMS), the American Hospital Association (AHA) and other stakeholders on a frequent basis regarding health care provisions being

proposed and implemented. Through advocacy efforts, the NHA and its members are able to influence federal policy and its impact on Nebraska hospitals.

The NHA advocates on behalf of our member hospitals in many ways at the federal level, some of which include the following:

- Conducted an annual meeting with Nebraska's congressional delegation and member hospitals in Washington, DC.
  - In May 2016, NHA staff and ten member hospitals attended the AHA Annual Meeting. While in DC, a group meeting was held with the Nebraska delegation and their staff. This is a critical meeting that allows NHA members to strengthen relationships with the delegation and share hospital-specific impacts of federal legislation and regulations.

NHA staff provided impact analyses to member hospitals on regulations proposed by CMS and legislation being considered by Congress. These analyses help hospitals better understand the financial impact of federal provisions.



In 2014, Nebraska hospitals contributed nearly \$1.1 billion (\$288 million of that in bad debt) to support programs that benefited their communities.

- Worked collaboratively with the leadership of Nebraska Medicaid to address various membership concerns throughout the year.
- Engaged in several discussions with Nebraska Medicaid, Nebraska Total Care, WellCare and UnitedHealthcare in preparation for the implementation of Heritage Health on January 1, 2017.

#### **Financial Stewardship**

- A "clean" annual audit was completed during 2016 with no material weaknesses or significant deficiencies identified.

## IMPROVING PATIENT CARE & FACILITY PRODUCTIVITY.



**Bio-Electronics** is a wholly-owned subsidiary company of the Nebraska Hospital Association (NHA), providing medical equipment service to hospitals and healthcare facilities in Nebraska, Wyoming, Kansas, Colorado, South Dakota and Iowa. Highly-qualified technicians service more than 250 hospitals and clinics each year.

We continue to provide services to numerous health care organizations, and have added or enhanced the services to many hospitals and medical clinics.



Bio-Electronics assists Nebraska Hospital Association member hospitals to achieve compliance with three deeming entities: The Joint Commission, DNVGL and the State of Nebraska Certification for Medicare and

Medicaid. Bio-Electronics has taken an active role in communication with the deeming agencies to clarify the rules and regulations to determine compliance for the member hospitals.

Bio-Electronics has provided enhanced services related to the workflow and equipment database to ensure equipment and test equipment is trackable and accountable to ensure quality for the patient at each facility. Bio-Electronic has made it possible for customers to utilize the Bio-Electronics systems to reflect the hospital's and clinic's own bio-medical system to mirror the proven systems developed by Bio-Electronics. This provides responsibility and accountability for the facility and the patient.

Two in-house programs were added to the Bio-Electronics accounts in the past year with the in-house programs numbering three for the organization. Bio-Electronics continues to serve approximately 200+ contracted health care customers. Bio-Electronics has serve as a back-up service for customers who experience shortages in workforces related to the bio-medical services. Agreements for one to six months have been utilized to ensure the facility is up to date with compliance in the established preventive maintenance programs.



Bio-Electronics completed the second year of efforts in working with Mediserve, to reduce the manufacturers maintenance contract cost to the hospitals in the Bio-Electronics system. The average amount of savings realized by

the 12 hospitals is a savings of 15 percent over what the hospital was spending for a manufacturers maintenance contract, utilizing the existing manufacturer's service personnel.

Bio-Electronics is actively developing relationships with imaging vendors to provide equipment that will meet the proposed revisions for digital readers (DRs) with selected customers. This change could provide relief to customers in reducing the loss of revenue with existing systems.

To date, Bio-Electronics has provided DR equipment to approximately six high-volume surgery centers and clinics.

Bio-Electronics stands ready to provide services to new and existing customers to assure compliance and meet the quality needs of the organization.
