Recapturing the Joy in Health Care

Joseph S. Bujak, MD, FACP, Vice President, Medical Affairs, Kootenai Medical Center - Coeur d'Alene, ID

This keynote presentation will examine the factors that promote a sense of pride and fulfillment in the health care workplace. Why are they in short supply? What can leaders do to restore them?

Dr. Joseph Bujak currently serves as vice-president, medical affairs for Kootenai Medical Center, Coeur d'Alene, Idaho, where he has organizational responsibility for performance improvement and outcomes measurement. He is a frequently requested speaker, facilitator and consultant on issues related to health care organization-physician relationships, clinical quality and patient safety, and leading and managing transformational change.

Dr. Bujak graduated Phi Beta Kappa from Rutgers University. He received his medical degree from the University of Rochester where he was elected to Alpha Omega Alpha. He and Tom Atchison co-authored the book Leading Transformational Change: The Physician-Executive Partnership. His new book, Inside the Physician Mind: Finding Common Ground with Doctors, was published in July of 2008.

Session 1: Building Successful Physician Relationships That Last

Joseph S. Bujak, MD, FACP, Vice President, Medical Affairs, Kootenai Medical Center - Coeur d'Alene, ID

This session will look at the changing world of HCO-Physician relationships, examine the forces that are transforming the industry, describe how physicians are responding, and identify the avenue to building effective communication and trust—the two most important elements essential to building sustainable excellence.

Session 2: Board Surveys: The Good, Bad and Ugly

Tracy E. Houston, Board Advisory Consultant, Board Resource Services - Denver, CO

How does a board know if they are doing a good job? Increasingly, the scope of a trustees' fiduciary obligations to the organization and its stakeholders is being redefined to require far more active participation and aggressive oversight of the management and overall direction of the organization. Boards that create extraordinary value design an environment that encourages rich dialog. A board survey—done correctly—provides critical feedback and sparks lively discussion. At the end of this session, the participant will be able to understand the components of a well-designed board survey process; understand how to create an environment of continuous improvement at the board level; and understand how to help the board step aside from a "code of civility" and move to greater effectiveness.

Tracy Houston focuses on leadership, strategy and risk management. She consults primarily with directors, presidents and senior officers providing input on high level, sensitive and complex issues. Houston was one of the nation's youngest women to sit on a board in the electric utility sector where she provided leadership during a period of industry change driven by deregulation, privatization, technology and globalization forces. She has provided strategic counsel at the congressional, state and local levels.

Session 3: Conflicts of Interest on Boards

Pamela Knecht, President, ACCORD LIMITED - Chicago, IL

The heightened scrutiny of hospitals and their boards by the Senate Finance Committee, state attorneys general and the Internal Revenue Service (IRS), among others, has caused board members to pay much closer attention to the issues of independence and conflicts of interest. In particular, the revised instructions for filing the IRS Form 990 have provided new definitions of "independent" board members and underscored the IRS' deep concern about conflict of interest management. This presentation will help board members understand the issues surrounding conflicts of interest and provides specific ideas for ensuring that boards' practices in this area are beyond reproach. Special attention will be paid to the complicated issue of physician board members.

Pam Knecht specializes in health care governance effectiveness, strategic planning, organizational development and hospitalphysician alignment. She was named a Governance Advisor for The Governance Institute in 2007, and is a frequent speaker and facilitator at board retreats and health care conferences across the country. Knecht has authored numerous articles and white papers for the AHA's Trustee Magazine. The Governance Institute's BoardRoom Press, SHSMD's Spectrum Journal, and ACHE's Healthcare Executive.

Session 4: Tacking Through the Turbulent Capital Markets

Alan Spidel, Regional Vice President, and Matt Lindsay, Vice President, Lancaster Pollard - Columbus, OH

In sailing, tacking is the use of zig-zag movement to go forward against the wind. It requires careful maneuvering and adapting to constant change—coasting doesn't work—and hospitals need to learn how to do it to successfully navigate in the current capital market. Endowments have experienced nightmarish losses, borrowing interest rates have skyrocketed, and covenants have significantly tightened.

This session will review the current market situation, help attendees evaluate the impact of economic changes on their investment portfolios and existing/future debt, and set out best practices for integrating strategic and capital plans in turbulent markets.

Alan Spidel and Matt Lindsay specialize in providing capital funding and financial advisory services to the senior living, health care, affordable housing and private education sectors. Spidel is a Healthcare Financial Management Association Follmer Bronze Merit Award recipient. He has published financial articles in the HFMA publications hfm and Big Business for Not-So-Big Hospitals and has been quoted in HealthLeaders Media and various state-level association newsletters. Lindsay is the senior banker responsible for the Northwest states and is responsible for all details involved in the underwriting and closing processes. He is focused on community health care and senior living, and has structured a range of bond transactions and mortgage loans for expansion, new construction and refinance projects.

Session 5: Designing a Greener Hospital

Kenner Kingston, AIA, LEED, AP, Architectural Nexus - Salt Lake City, UT; and Cary Smith, CGD CEM, Sound Geothermal Corporation -Sandy, UT

The language of sustainable design is now an entrenched concept in health care design and construction, yet many organizations and their facilities have only had the opportunity to address green design, construction and stewardship in a modest manner. These limitations are primarily the result of the complexity associated with health care projects, the complexity of the organizations that initiate them, as well as the complexity of the topic itself. Despite this, reasonable solutions are available to both existing and new facilities.

This presentation will provide an overview of sustainable design focusing on practical solutions for hospitals and will include a discussion of the similarities, differences and synergies between applicable rating systems. This overview will be followed by a case study at Uintah Basin Medical Center in Roosevelt, Utah for a high performance earth coupled heating and cooling system including a campus-wide energy sharing strategy.

Kenner Kingston was the first LEED accredited professional at Architectural Nexus-and one of the first architects in Utah to receive this accreditation. LEED is the highest rating standard for sustainable building projects administered by the United States Green Building Council. He constructed and led the "Green Team" at Architectural Nexus.

Cary Smith is a founding partner and CEO of Sound Geothermal Corporation. He has over 35 years of experience in the fields of energy consulting, exploration and development, and energy systems design. Smith is responsible for the majority of the large commercial and school designs in SGT's portfolio and has designed several successful health care applications.

The Heart of Governance: Why Teamwork is Critical to Your Board's **Performance**

Mac McCrary, President, The McCrary Company - Morganton, NC

We have entered an era of increased accountability for boards of non-profit organizations. Against the background of continuing governance meltdowns in the publicly traded sector community-owned health care boards are being asked tough, pointed questions about such complex issues as executive compensation, clinical outcomes and collection practices for uncompensated care. But as smart boards consider how to assess and improve their performance in this hostile environment, they struggle with questions: What board development process should we adopt? What resources do we need? What should we do first? How long will it take? How do we overcome the obstacles we will inevitably confront?

Join us for a logical, practical discussion that will help your board leaders go beyond just knowing about the issues they will face in the future. This session will help your board begin to make sense of these concepts and understand how to use them to provide more value to the organization they serve. You'll leave this session with a solid understanding of what it takes to implement the technologies required to improve the contribution your board makes and to improve the satisfaction you get from being a member of an effective governing team.

Mac McCrary is an experienced hospital trustee. Over the years, he has held a number of board leadership positions such as chairman, treasurer and chair of numerous committees and task forces in hospitals and other health care related organizations. He has hands-on experience with organizations that were experiencing rapid growth, confronting financial difficulties, going through affiliations, changing CEOs, reorganizing their governance structure and facing many other issues.

Competency-Based Governance: Conclusions of the Blue Ribbon Panel on Trustee Core Competencies

John R. Combes, MD, President and Chief Operating Officer, Center for Healthcare Governance - Chicago, IL

Both for-profit and non-profit organization failures have stimulated calls for greater governing board performance and accountability. However, boards need practical guidance to help achieve this goal. The Hospital Research and Education Trust (HRET) and the Center for Healthcare Governance, with funding from Hospira, Inc., convened a Blue Ribbon Panel on Trustee Core Competencies to examine the nature of competencies and how they can be developed and applied to improve health care governance. In this session, you will learn about the panel's work and recommendations, including:

- What competencies really are, and how they differ from the way competencies are viewed and applied in health care governance today.
- Sample governance core competencies and how they might be applied to the work of health care boards, as well as suggestions to further strengthen the link between competencies and board and organizational performance.

John R. Combes, MD, is the President and COO of the Center for Healthcare Governance (CHG), an American Hospital Association (AHA) affiliate organization. CHG is a dynamic community of board members, executives and thought leaders dedicated to advancing excellence, innovation and accountability in health care governance through education, tool development and research. Dr. Combes also serves as Senior Fellow at HRET. In that role, he focuses on quality and leadership issues in patient safety, end of life care and clinical performance improvement.

Session 6: The Heart of Governance: An Implementation Guide

Mac McCrary, President, The McCrary Company - Morganton, NC

Fortunately, the practices required to build and maintain effective boards are widely available and easily understood. Unfortunately, implementing those practices can be challenging. This session is intended to be a common sense "how to" guide for using the concepts learned here.

This session will provide you with a solid understanding of what it takes to implement the technologies required to improve the contribution your board makes and to improve the satisfaction you get from being a member of an effective governing team.

Session 7: Effective Selection, Recruitment, Orientation and Education of Health Care **Boards**

Luanne R. Armstrong, Vice President, Governance, Texas Health Resources (THR) - Arlington, TX

Selecting and recruiting board members in today's challenging environment is no easy task. Recruiting based on "who you know" in the community may no longer be feasible or desirable, and may not provide the depth of competencies and skills needed by the board. Recruiting in the post-corporate governance scandal environment is also challenging, as potential board members may not wish to expose themselves or their assets to risk. Once they agree to serve on the board, how do you orient them and provide ongoing education regarding health care and your organization? This presentation will focus on successful strategies for the recruitment and selection of board members, as well as their orientation, ongoing education and communication in order to prepare them to effectively govern the organization.

Luanne Armstrong has over 25 years of experience in health care governance and health and corporate law. Working with the THR executive team, Armstrong designs and implements a multi-year system governance strategy addressing competencybased board relationships, education, orientation, communication, committee structure and self-assessments, as well as linking the strategy between THR and its subsidiary corporations. She administers and coordinates all aspects of governance/board operations for 27 boards.

Session 8: RAC Update — What Every Hospital Trustee Needs to Know

Glenn Krauss, BBA, RHIA, CCS, CCS-P, CPUR, FCS, PCS, C-DIS, QHR, Senior Coding and Chargemaster Consultant, QHR - Brentwood, TN

The RAC program will soon have not only a financial but an operational impact on most health care institutions nationwide. In this session, you will learn which risk areas RACs are expected to target nationwide; how to assess your hospital's risk; how to determine if your hospital is prepared for a RAC audit; why physicians are a key player in protecting your hospital from False Claims Act actions based on the lack of medical necessity; the 5-step appeal process; and how to protect your organization and reduce your risk exposure moving forward.

Glenn Krauss has more than 15 years of experience in the health care industry as a consultant and has held various staff positions in numerous health care systems. His business background in and experience as a practicing coder and as a consultant in DRGs, ICD-9-CM, Chargemaster, billing, APCs and CPT-4 coding enable him to effectively combine a working knowledge of hospital management with the importance of a functioning and effective health information management department.

Session 9: Orientation to Health Care Payment Systems in 2009

Gregg Redfield, CMA, Vice President, Finance, Minnesota Hospital Association - St. Paul, MN

Consumer-driven health care, new accounts receivable concerns, Medicare Advantage plans, transparency, pre-authorizations, bad debts and high-deductible plans in the United States have created a number of issues as traditional reimbursement is changing across the country. This session will focus on the basic sources and types of payment, knowing your payer mix, and key payment issues and concerns for 2009—for both health care facilities and their patients. These changes include new payment methodologies, patient access concerns, health plan options, and potential cash flow problems for both large and small facilities. You will learn what these changes are and how they may impact significant portions of your reimbursement.

Gregg Redfield has over 19 years of auditing, financial and operational experience in the health care industry and has presented at both regional and national education sessions for a variety of organizations. He works with Minnesota member hospitals and boards on all areas of reimbursement and finance, and provides research and policy analysis related to state and federal advocacy. Redfield's background includes work in health care consulting for two large Minnesota hospital systems and a regional fiscal intermediary.
