#### Session 1: Finance for the Community Trustee

Paul Traczek, CPA, Wipfli, LLP - Eau Claire, WI

## Session 2: The Intersection Between Governance and Consumer Loyalty

Healthcare consumers have more options and more information than ever. So, how do we break through the noise and ensure our consumers stay loyal to us? And what does this have to do with the board? They are all related, and making a change in any of those areas hinges on the board.

#### Session 3: How to Create Curiosity on Your Board

Asking strategic questions is one of the most powerful tools a board can wield. Yet, far too often board members focus on operational details, thus missing the chance for generative dialogue. Developing a mindset of curiosity among board leaders increases their ability to take a strategic view. Curious leaders are more likely to view challenges and uncertain times as novel opportunities to develop innovative solutions. Karma Bass will explain how curiosity – when deployed well – can foster better relationships among board, management and physician leaders, and enable more effective governance. She will provide ideas for fostering curiosity on your board and examples of boards who have done this well.

#### **Keynote Address**

## An Ethical Case for Excellence in Healthcare Delivery

Benjamin Anderson, MBA, MHCDS, CEO, Kearny County Hospital Lakin, KS

As the U.S. grapples with the implementation of legislation that could afford all citizens access to healthcare coverage, rural communities face additional challenges. First, insurers are still paying generously through the Critical Access Hospital program for high-cost inpatient and emergency services with very little focus on incentivizing population heath. To make matters more difficult, rural healthcare delivery systems often lack the basic primary care and community-based infrastructure to properly manage the health of their populations. Put simply, even if insurers incentivized interventions that would lead to better overall outcomes for people, those services are not available in many rural communities. In this presentation, Benjamin Anderson tells the story of the rapid growth and transformation of Kearny County Hospital, a frontier healthcare delivery system in one of the United States' most culturally diverse and medically underserved areas. He addresses the fatalism that has become common in rural communities, while referencing the Four Principles of Biomedical Ethics to make a compelling case for essential steps to effective, sustainable reform.

#### Session 4: Post-Acute Transitional Care Utilizing the Swing Bed Program: Understanding the Quality and Financial Impact to Your Critical Access Hospital

Mark Lindsay, MD, Assistant Professor, Mayo Clinic College of Medicine Rochester, MN

Rural residents across the country have access to fewer healthcare services, lower economic and insurance status, fewer physicians per capita and higher chronic disease rates than their urban peers. More rural hospitals have closed recently than in the prior 15 years combined (*Morgan, 2014*). Maintaining long-term viability of Critical Access Hospitals will be essential for rural healthcare delivery. Furthermore, 20 percent of Medicare patients are hospitalized each year and almost half require care after being discharged from the hospital to assist them in their recovery from serious illnesses.

In this session, participants will be able to understand the value of developing high quality post-acute transitional care in CAHs in response to a growing patient population, and demands and challenges in acute care hospitals.

#### Session 5: Reimbursement Models of the Future: A Look at Proposed Models and Their Potential Impacts on the Rural Provider

Ralph J. Llewellyn, CPA, CHFP, Partner, Eide Bailly - Fargo, ND

What is going to happen with Critical Access Hospital reimbursement? Will it change? How will it change? In this session, we will look at proposed alternative reimbursement models for rural facilities and how they might impact your facility and community. If these models come into play, what strategy/solution is best for your community? We will discuss the benefits of these proposed models, along with any unforeseen challenges.

## **Session 6:** Population Health: Measuring and Improving Outcomes with a Diverse Population

Benjamin Anderson, MBA, MHCDS, CEO, Kearny County Hospital - Lakin, KS

In the summer of 2016, Kearny County Hospital partnered with the University of Kansas School of Medicine and students from Baylor University to successfully survey 85 percent of the households in the racially diverse cities of Deerfield and Lakin, Kansas. Through community-based participatory research methods, the survey sought to understand the community members' definition of health and wellness, as well as their awareness of and desire for services. Most notably, there were clear and measurable differences in the way various races, genders and social classes answered the same questions. Through telling the story of Kearny County Hospital's quest to care for southwest Kansas people originating from over 30 countries, Benjamin Anderson introduces tools and makes a strong case for pursuing measurable and equitable health outcomes for all people.

#### Session 7: Addressing Addiction: Moab Regional Hospital's Addiction Medicine Program

Jennifer Sadoff, CEO, Moab Regional Hospital - Moab, UT

In 2015, Moab Regional Hospital (MRH) in Moab, Utah worked with several other area healthcare providers to identify capacity building needs to address substance use disorders in their remote region. The following year Moab Regional partnered with Blue Mountain Hospital, San Juan Hospital and Utah Navajo Health Systems to bring a visiting addiction medicine specialist from the University of Utah to assist in developing an Addiction Medicine Program for the region. MRH started their own Addiction Medicine Program in 2017.

This session will discuss the process the hospital took to coordinate the partnership, the key elements of the Addiction Medicine Program, as well as efforts to stem future addiction through screening and the development of a prevention coalition in their community.
