# **Course Curriculum (all times CT)**

#### Part 1: Feb. 6, 9 - 11 a.m.

Topics covered include a general overview, CMS survey memos, surveyor training material, hospital deficiency reports, CMS 3 worksheets, required education, hard hit areas, board and medical staff, budget, contracts, emergency services, medical records, and standing orders.

## Part 2: Feb. 13, 9 - 11 a.m.

The focus is on patient rights and includes the following topics: advance directives, consent, interpreters, grievances, exercise of patient rights, disclosures, privacy, safety, ligature risks, abuse and neglect, and visitation.

The focus is nursing and pharmacy.

### Part 4: Feb. 27, 9 - 11 a.m.

Topics covered include quality assessment and performance improvement (QAPI), medical staff and hospital leadership, food and dietary services, radiology, laboratory and look back program, utilization review, and physical environment.

Topics covered include infection control; discharge planning; organ and tissue procurement; surgical and anesthesia, outpatient, emergency; and respiratory and rehabilitation services.
