OVERVIEW

Every hospital that accepts Medicare or Medicaid must be in compliance with these regulations and interpretive guidelines.

Part 5 of this series will concentrate on infection control and 2018 proposed changes, discharge planning, organ, tissues and eye procurement, surgical and anesthesia services, outpatient services and proposed changes and rehabilitation and respiratory services.
