Aligning Population Health and Quality Metrics With Small Physician Practices

OVERVIEW

Small independent community based practices are facing challenges associated with the multitude of payer requirements, population health management initiatives as well as increasing the quality of care, while utilizing an Electronic Health Record (EHR). The New England Quality Care Alliance (NEQCA) is a network of physicians, affiliated with Tufts Medical Center in Boston, MA, including almost 1,800 physicians comprised of various Local Care Organizations (LCOs) located in and around the Boston area. The Metrowest Accountable Healthcare Organization 9MWAHO) is one of the LCOs within NEQCA that includes physicians employed by Metrowest Medical Center as well as independent small providers in the community. NEQCA has developed a unique approach to help small community based practices meet necessary requirements and this webinar will give an overview of that approach that has been applied in groups like MWAHO.

The priority of each primary care physician is to practice high quality and efficient care for his or her patients. The intent for these small physician practices is to leverage the EHR as a tool to improve quality, while also meeting the various quality measures and reporting requirements.
