OVERVIEW

Hospitals and healthcare providers can only start the move from volume to value by changing payment methodologies and reorganizing providers into new structures. In order to truly produce higher value (quality per unit of cost), providers will have to actually re-tool the care delivery system so that it reliably produces high quality in a cost efficient manner. This webinar will describe a systematic approach, known as the Care Process Design System (CPDS), to driving high-value care delivery. The CPDS uses tested methodologies and technologies to design care processes, measure outcomes (quality and cost) and use those outcomes to practice data-driven process improvement.
