# Coding Scenarios Using ICD-10-PCS Webinar #120214-WI

## **OVERVIEW**

This session will help participants differentiate between the seven approaches used within PCS. Participants will also learn to use the body part and device keys in coding case scenarios in ICD-10-PCS. Participants will learn to make root operation selections and assign all of the characters for the codes included in 10 common ICD-10-PCS cases. This session will prepare participants for the December 9, 2014 webinar focused on complex coding decisions, but is not a prerequisite.

- Identify the root operations assigned for 10 common PCS cases.
- Determine the remaining characters in each code for 10 common PCS cases.
