Course Curriculum

This webinar will focus on the proposed revisions to the payment policies for hospital inpatient and outpatient departments, including, for example, proposed 340B payment reforms, expansion of site-neutral payments for off-campus provider-based departments, and changes in hospital price transparency rules and quality and value-based payment measures. The IPPS CY 2019 proposed rule was released by Centers for Medicare and Medicaid Services (CMS) on May 7, 2018 and the OPPS CY 2019 proposed rule was released July 25, 2018. Specifically, the webinar will cover major changes proposed by CMS in each rule and CMS's requests for commentary arising under each, including responses and commentary that reflect upon anticipated impacts to hospitals and health systems. Those proposed changes include:

- Proposed changes to payment and tracking of off-campus provider-based emergency departments, off-campus provider-based departments (PBDs), and service lines in excepted off-campus PBDs;
- 2. Payments for separately payable, covered outpatient drugs and biologicals acquired under the 340B Program;
- 3. Updates to inpatient payment, including adjustments quality and value-based measures;
- 4. And expansion of price transparency requirements.
