#### Schedule I

Schedule I drugs, substances, or chemicals are defined as drugs with no currently accepted medical use and a high potential for abuse. Some examples of Schedule I drugs are: heroin, lysergic acid diethylamide (LSD), marijuana (cannabis), 3,4-methylenedioxymethamphetamine (ecstasy), methaqualone, and peyote.



### Nebraska Voter Initiative 437

Object Statement:

The object of this petition is to enact a statute that makes penalties inapplicable under state and local law for the use, possession, and acquisition of limited quantities of cannabis for medical purposes by a qualified patient with a written recommendation from a health care practitioner, and for a caregiver to assist a qualified patient in these activities.

Dear Governor Pillen,

Pursuant to Nebraska Revised Statute § 84-901.04, the Nebraska Medical Cannabis Commission is requesting the adoption of emergency regulations to fully implement the Nebraska Medical Cannabis Regulation Act as required by Nebraska Revised Statute § 71-24,110 and § 71-24,111 and replace the previously issued emergency regulations. In support thereof the Commission states the Act requires the criteria for the acceptance of applications for registered establishments be established by July 1, 2025, and for the Commission to begin granting licenses by October 1, 2025. Without these regulations establishments will not be able to submit applications nor will the commission be able to review said applications to determine eligibility to dispense, manufacture, cultivate or transport under the Act. Failure to do so would force Nebraskans to seek medical cannabis or similar products from unregulated and potentially harmful sources. The inability to obtain medical cannabis from a Nebraska regulated establishment relates to the health, safety, or welfare of Nebraska residents.

Pursuant to your letter, the Commission revised the emergency regulation to place a limit on the number of flowering plants for each cultivator type. Our research suggests one plant is necessary per two medical cannabis patients. It is estimated approximately 20,000 Nebraskans could be medical cannabis patients. To ensure enough product for this number of potential patients, 10,000 flowering plants would be necessary. The regulations authorize each cultivator to possess no more than one thousand two hundred fifty (1,250) flowering plants. Four cultivators with two harvests a year should result in a sufficient number of plants.

Due to the time-limited authority of emergency regulations, the Commission will engage in the formal rulemaking process for these regulations.

MEDICAL MARIJUANA, INC., ET AL. v. HORN

CERTIORARI TO THE UNITED STATES COURT OF APPEALS FOR THE SECOND CIRCUIT

No. 23–365. Argued October 15, 2024—Decided April 2, 2025

Seeking relief from his accident-related chronic pain, Douglas Horn purchased and began taking "Dixie X," a purportedly THC-free, non-psychoactive CBD tincture produced by Medical Marijuana, Inc. A few weeks later, however, Horn's employer selected him for random drug screening, and Horn tested positive for THC. After he refused to participate in a substance abuse program, his employer fired him. Horn
