Keynote Presenters

Steve Tremain, MD, is a Physician Improvement Advisor with Cynosure Health. Board certified for 35 years in Family Medicine and now retired from active clinical practice, Dr. Tremain worked as a hospital-based clinician and teacher, and served as Chief Medical Officer for a large integrated public system for over 20 years. He was the executive sponsor for improvement teams that were awarded mentor status by the Institute for Healthcare Improvement in the areas of medication reconciliation, rapid response teams and ventilator associated pneumonia. Currently Dr. Tremain works as a national and international Improvement Advisor and serves as the national clinical lead or co-lead for the American Hospital Association/HRET HIIN efforts to improve antibiotic stewardship and to reduce harm from adverse drug events, VTE, sepsis and C-difficile. In addition, he teaches and consults regarding the culture of safety, process reliability, leadership and physician engagement throughout the United States and Canada. Dr. Tremain is a Certified Physician Executive and a Fellow of the American College of Physician Executives. He earned his MD degree from the UCLA School of Medicine.

Michael Topchik has been supporting rural health network initiatives for more than a decade. He consults widely with such statewide initiatives utilizing data and benchmarking to support performance improvement consulting. He has an MA from Columbia University in New York.

Jamie Bland, DNP, RN-BC, is CEO of Nebraska Health Information Initiative (NeHii). Prior to joining NeHii, she worked with a provider organization and at the VA Midwest Region (VISN 23) office in Eagan, MN as the PCMH and health promotion disease prevention program manager for the primary care service line. She has extensive experience establishing and leading care management, population health and clinical quality initiatives.

Margaret Brockman, MSN, BSN, ASN, joined the Office of Community & Rural Health in July 2013 for the State of Nebraska. As a registered nurse, she has been employed in both rural and urban hospitals. Gail Brondum is Executive Director of the Nebraska Coalition for Patient Safety. She receives and reviews event investigations, including RCAs and action plans from member healthcare organizations, providing feedback and assistance in conducting investigations, determining root causes, and developing action plans. She was previously Director of Clinical Quality with Blue Cross and Blue Shield of Nebraska, investigating adverse events reported to them. She was also previously Operations Manager of Quality at Bergan Mercy Medical Center and Director of Quality & Risk at Pender Community Hospital.

Marty Fattig, MHA, has been involved in healthcare for over 40 years. He began his career as a bench Medical Technologist. He expanded his technical skills to include radiology and electrocardiology. He is currently the CEO of Nemaha County Hospital in Auburn, where he led the effort to install their EHR in 2004. He is Chairman of the Rural Health Advisory Commission, a member of the CAH Advisory Council, and the CAH Advisory Board on Quality. He has served on the Region 6 Regional Policy Board of the American Hospital Association. He is Co-Chair of the Nebraska eHealth Council and is currently the Chair of the Nebraska Hospital Association Board of Directors. He has also served as a member of the HIT Policy Committee Meaningful Use Group Workgroup.

Laura Grangaard Johnson is a senior research analyst at Stratis Health. She provides analytic and program support for a wide range of state, regional, and national scale projects that address quality of care in healthcare and community settings. Laura has worked on a variety of projects specifically supporting rural providers and programs, including several state and national-scale projects focused on palliative care, a CMS Emergency Department Transfer Communication (EDTC) Special Innovation Project, and the FORHP-funded RQITA work. She has supported national- scale data collection for the EDTC measure, both through the CMS EDTC Special Innovation Project, as well as for MBQIP data collection under RQITA.

Katherine Jones, PT, PhD, is a physical therapist and health services researcher. She is the current President of the Board of Directors of the Nebraska Coalition for Patient Safety and the manager of Jones Health Services Consulting. She is certified as a TeamSTEPPS Master Trainer, Just Culture Champion, and Patient Safety Officer. While on faculty at the University of Nebraska Medical Center from 2004 through June 2018, she was the principal investigator for two Partnerships in Implementing Patient Safety grants funded by the Agency for Healthcare Research and Quality that sought to improve medication safety (2005 – 2007) and fall risk reduction (2012 – 2015) in Nebraska's Critical Access Hospitals. Dr. Jones is nationally recognized for her expertise in safety culture assessment and teamwork in small rural hospitals.

Dr. Jared Kramer, board member at Bryan Health Connect, and PHO board member and provider at Howard County Medical Center (HCMC) in St. Paul, has helped to initiate the birth of the ACO at HCMC through Prairie Health Ventures by helping with the development of procedures and policies to improve health of our patients via the set measures of the ACO and pushed for staff to work to the peak of their credentials.

Beth Malina BSN, RN, CNRN, is Director of Quality and System Improvement for Kansas, Nebraska, and Kansas City for the American Heart Association/American Stroke Association. She supports hospitals and EMS in using *Get With The Guidelines®* for stroke, heart failure, resuscitation, afib, and Acute Coronary Syndrome. Beth has worked in critical care, interventional radiology, labor and delivery and most recently as a stroke coordinator. **Leslie Marsh, MSN, MBA, RN,** is CEO of Lexington Regional Health Center. A rural, state-of-the-art 25-bed critical access hospital with 24/7 emergency room services, Lexington Regional is also comprised of an Urgent & Primary Care Clinic, an Outpatient Services Center and three Rural Health Clinics. An active advocate for health care quality and safety, Leslie serves on many health-related boards including the American Hospital Association's Region 6 Policy Board. Under Leslie's resolute leadership, along with a dedicated team, Lexington Regional Health Center has realized an 80% reduction in readmissions. Lexington Regional's work on quality has translated to a \$289,000 in savings for the hospital, which corresponds to an increase in high-quality performance.

David Palm, BS, MS, PhD, is Associate Professor in the Department of Health Services Research and Policy in the College of Public Health at the University of Nebraska Medical Center. He has conducted studies about the linkages between public health, primary care clinics, and hospitals in 2017 and 2018. He has also analyzed the community health needs assessments and implementation plans developed by hospitals and compared the priorities and strategies with those in the community health improvement plans of local health departments.

Karen Pribnow, RN, MSN, OCN, CN-BN, is a Breast Cancer Nurse Navigator at CHI Health St. Elizabeth. She has over 30 years of oncology experience in a variety of settings including hospital, clinic, home infusion and research, and certified in oncology nursing for 30 years. For the past 9 years, she has been a breast cancer nurse navigator at CHI Health St. Elizabeth in Lincoln. She received certification in breast navigation, meeting with ladies when they come in for biopsies, and providing support. She navigates all breast cancer patients throughout their journey and provides a survivorship care plan for them when done with treatment. She also facilitates breast cancer support groups.
