Individual donors must be employed by a member hospital. Corporate donors must be a NHA Services Preferred Business Partner or a NHA Affiliate Member. Nonprofit organizations are not allowed to contribute to political action committees or candidates.

Contributions or gifts to the AHAPAC/NHAPAC are not deductible as charitable contributions for federal income tax purposes. Your contribution is important to us, but we want to emphasize that all contributions are voluntary and have no impact on your job status, performance review, compensation or employment. Any giving guideline is merely a suggestion. Any amount given or the decision not to give will not advantage or disadvantage you. Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation and name of employer of individuals whose contributions exceed \$200 in a calendar year (January - December). Contributions to AHAPAC/NHAPAC will be used for a political purpose.
